Scientific and other public dissemination and societal impact:

As part of our work at Fafo we contribute regularly with keynotes and papers at international and national scientific conferences, along with a constant flow of introductions, lectures, and in debates at conferences, seminars, courses, congresses and alike among the social partner organizations, NGOs, and at governmental arrangements – nationally and internationally – including in a few instances court trials. For my part that has over the years varied between 20 and 40 stunts per year, and it would go too far to list or count these things.

Part of our work is also to contribute to public debate, which over the years has implied a sizeable number of newspaper chronicles, op-eds, and participation in societal debates about contested issues, along with participation as experts in radio and TV-coverage of such issues.

Today, these things have now got renewed attention, as part of the scientific authorities' rediscovery of the fact that not only scientific publications are of value to society but also researchers' contributions to knowledge-based policy formation i.e. the so-called "impact factor". Hence, researchers are asked to document such "impact". For researchers at Fafo, where these aspects of research have always been considered as an essential element in the purpose and meaning of our work, it goes without saying that it's a lot to dig into over the years but that account will have to wait until later.
